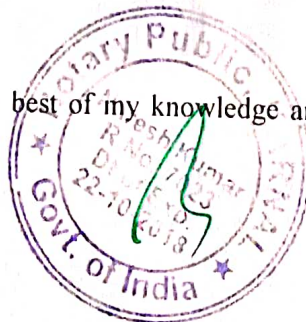
AFFIDAVIT
